- ŽELEZNICE SRDCEM Endowment Fund we already collected CZK 26 million to provide financial support of railway staff members and their families in difficult life situations
- Participation in other social projects: SOS Children's Villages, Christmas Grandchildren, Earth Day
- Extra social fund contributions social contributions, contributions to improve working environment, contributions to cultural and sports events, recreations or camps for children.
- Work-life balance we offer shortened working weeks according to the job specialization. Parents can also use corporate children's groups for their small kids or summer or winter camps organized by ČD.
- Age management system within social fund contributions we offer health and recovery programs for selected professions with high physical load
- Cooperation with high schools and universities Scholarship program known as ČéDés, financial contribution to build a relax zone for students of the Faculty of Transport Engineering, University of Pardubice


